



- Scale furthering the rule of law by creating case digests and an index of the entire case law of Liberia through Lawyers Without Borders, so that judges can apply case precedent.

As with all our pro bono work, we have a strong focus on impact – selecting practical projects where our efforts and time will make the most effective difference. Using the framework of the Sustainable Development Goals we are seeking to grow the impact of our activity through greater collaboration.

We collaborated to improve treatment of child victims of trafficking, forced labour, and sexual exploitation in court processes in Cambodia, through Hagar International.


